One of our commitments to orchid exhibitors is to provide opportunities to have your orchids evaluated, and to allow more exhibitors and society members to observe monthly judging processes.

To this goal, we are going to split our monthly judging's to be held both in the Lower Mainland and on Vancouver Island. We have secured a convenient venue in the Victoria area, as well as maintaining our meeting place at Sea Island Community Centre. ### CVIOS MINUTES OF GENERAL MEETING

May 27, 2017

Connie brought the meeting to order at 12:05 with 15 members present.

Mike moved acceptance of the April 22 minutes, Bob 2nd and motion carried.

Correspondence included the March, April and May AOS Bulletins and the most recent Orchid Digest. As the Library was not available, a signup sheet was put on the front table for people to sign out these issues to be returned at the June meeting.

Treasurer: In Joann's absence Laurie gave the Current Balance.

Programs: Alexey indicated he would be in contact with Bryan regarding our June Program and was working on lining up speakers for the fall. He indicated that Fred Clarke may be available and that there may be some other joint society speakers that we could share.

Alexey also told members about the latest news re the AOS Pacific Northwest Judging Centre (Richmond), conversion to becoming the more independent Western Canada Judging Centre. This means that judging sessions will alternate between Vancouver and Victoria, giving much greater access for judging. He briefly explained the judging process and what the judges look for when considering awarding an orchid with an AOS award. He also outlined the types of AOS awards given and encouraged all members to enter their plants for judging if they feel they have merit.

Show Reminder: Will be taking place September 29 - October 1 at Nanaimo North Town Centre with Orchid Registration and Display Set Up on Thursday the 28th. #### **CVIOS Website Report**

I thought it was about time that I reported to the membership about our website.

When I took over the maintenance of our site it was up and running through Go Daddy and was up loaded via the program Front Page 03. This was OK at first but as time went on, any problems I had with the server was next to impossible to fix. Finally, I found a reliable local server here in Sooke. It is so much easier, now when I have a problem I just drive to the office and get it fixed. In April, we had a problem with the server that took about 2 weeks to fix. The server made a bad move. He changed his portal from Shaw to TELUS and up graded his hardware, all at the same time. This created problems on multiple fronts.

Front Page is the other problem. This program was published in 2003 and was designed to run on Windows XP. Windows 10 still accepts the program but when Windows comes up with a new operating system, who knows. I have tried three different programs over the last few years but to no avail. Most new systems are made for bloggers and will not handle the data we have on our site. If there is anyone out there that can lead me in the right direction please contact me.

Our site gets about 6 million hits per year, some months more than others, which is the most active of all the sites our server handles. I have been contacted by many people wanting more details about the CVIOS. One contact was from a grade 5 teacher in N. Carolina who used our site to introduce her students to Orchids.

### AOS JUDGING - TIPS TO MAKE YOUR PARTICIPATION MORE ENJOYABLE

The WCJC (Western Canada Judging Center) welcomes members and guests to AOS judging activities at Monthly Judging's and Show Judging's at society shows. You don't need to be an expert orchid grower to observe and everybody is welcome. However, there are a few tips to make your participation more enjoyable:

- 1. If you plan to attend and observe an AOS Judging at a society show, it would be courteous to contact the AOS Judging Chair of the show. (the Show Chair or show personnel should be able to direct you to the AOS Judging Chair). It is important for the Judging Chair to know who will be at the judging session since sometimes space might be limited.
- 2. If you plan to attend an AOS Monthly Judging, please plan to arrive at the venue 15-30 minutes before AOS Judging starts.
- 3. Please bring plants! (...to Monthly Judging's, assuming that, if you have plants for a society show they would already be in displays) Don't be shy, and don't prejudge your plants. You might not know what judges are looking for, and as we have witnessed numerous times, plants that were awarded at shows are plants that exhibitors brought as "fillers".
- 4. When you bring plants to a monthly judging or a show, please take care NOT to have any visible identification on the plant/pot that will let others know the plant(s) belong to you. Anonymity is important in AOS judging. To that regard, please do not discuss your plant with judges before judging is over. For example, going up to an AOS judge (or within earshot of one) and comment "I brought in this little thing over there, can you tell me if this is worthwhile?" would automatically disqualify that AOS judge from screening/nominating/discussing your plant for an AOS award.
- 5. If you have a plant that you would like to be evaluated at a monthly or show judging, please bring that to the Judging Chair's attention (and not to individual AOS judges). Judging Chairs are usually not in any teams hence will be able to keep the anonymity intact.
- 6. All plants brought to the monthly judging table (or entered into a society show display) will be considered eligible for AOS awards unless indicated otherwise (by a plant tag which states "not for AOS judging"). Note: inflorescences that have been screened at previous AOS judging activities (show/monthly judging) cannot be judged again on the same flowering and should bear the "not for AOS judging" tag.
- 7. Observers who wants to be "in the action" can request the Judging Chair to assign them to a team. While all members are welcomed to observe the AOS judging, please keep comments/questions until judging is over, or if an AOS judge from the judging team solicit comments from you.
- 8. Please be prepared that if your plant is awarded an AOS award, there will be a processing fee associated with the award (currently award fee is US\$40 for AOS members, US\$60 for non-AOS members)

Most of all, bring your plants and have fun! AOS judging is not as stuffy and regimented as some people think, and we do have fun during our judging meetings!
